**AN ORDINANCE OF THE CITY OF TROY, ILLINOIS  
AUTHORIZING THE DESTRUCTION OF AUDIO RECORDINGS IN ACCORD  
WITH SECTION 2.06(c) OF THE ILLINOIS OPEN MEETINGS ACT**

---

**WHEREAS**, Section 2.06(c) of the Illinois Open Meetings Act states that verbatim records (i.e. audio recordings) of meetings may be destroyed no less than eighteen (18) months after the completion of a recorded meeting; and

**WHEREAS**, attached hereto as Exhibit A is a list of audio recordings that have been reduced to written minutes and approved by the City Council in accord with the Illinois Open Meetings Act, and are more than eighteen (18) months old; and

**WHEREAS**, accordingly, under Section 2.06(c) of the Illinois Open Meetings Act, the Clerk is hereby authorized to effectuate the destruction of the audio recordings referenced in attached Exhibit A in accord with Illinois law.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF  
THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:**

- Section 1. That the City Council hereby determines that the preambles hereto are true and correct and are incorporated herein by reference as if fully set forth herein.
- Section 2. If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.
- Section 3. This Ordinance shall be effective upon its passage, signing and publication as required by law.



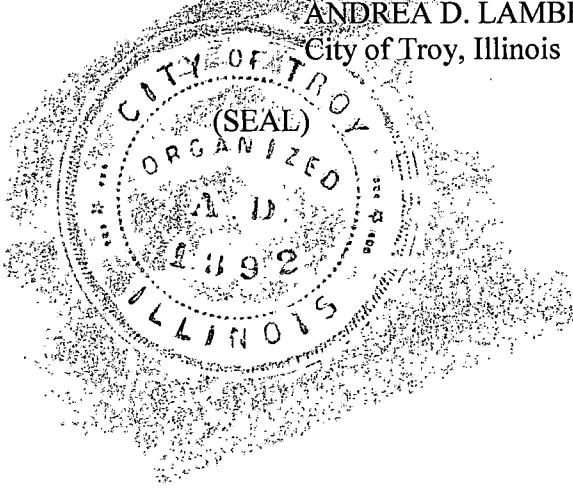
