## Ordinance No. 2017-06

### AN ORDINANCE OF THE CITY OF TROY, ILLINOIS, PROVIDING FOR THE INSTALLATION OF "NO PARKING" SIGNS AT A CERTAIN LOCATION IN THE CITY OF TROY, ILLINOIS

---

**WHEREAS**, upon order of the City Council of the City of Troy, Illinois, the Chief of Police has determined the need to improve safety at a certain location within the corporate limits of the City of Troy, Madison County, Illinois; and

**WHEREAS**, the City Council of the City of Troy, Illinois has determined that the public safety will be promoted by establishing "No Parking" signs at the location set forth by the Chief of Police;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS AS FOLLOWS:**

Section 1. That the City Council hereby determine that the preambles hereto are true and correct and are incorporated herein by reference as if fully set forth at this point.

Section 2. "No Parking" signs are hereby required and shall be installed as follows:

East- and North-Bound from the driveway at 208 Arrowhead Drive to the driveway at 210 Arrowhead Drive

East- and North-Bound from the driveway at 205 Arrowhead Drive to the intersection at Cobblestone Court and Arrowhead Drive

Section 3. A "No Parking" sign conforming to the Illinois Department of Transportation's standards and specifications, if applicable, shall be erected at the intersection described in Section 2 above, such intersection being within the City of Troy, Illinois. The location of this sign shall conform to the requirements of the Illinois Department of Transportation's standards and specifications, if applicable.

Section 4. Any person who disobeys the "No Parking" signs to be placed pursuant to this Ordinance shall be in violation of Chapter 72.23 of the Codified Ordinances of the City of Troy, and shall be in violation of our Codified Ordinances, and shall be fined not more than \$750.00 for each such offense.

Section 5. The Code of Ordinances of the City of Troy, Illinois, Chapter 74, Schedule II, is hereby amended to reflect the above described "No Parking" signs' placement.

Section 6. If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.

Section 7. This Ordinance shall be in full force and affect from and after its passage and approval and publication in pamphlet, according to the law.


