ORDINANCE NO. 2017 - 17

**AN ORDINANCE OF THE CITY OF TROY, ILLINOIS  
AUTHORIZING THE MAYOR TO EXECUTE AND THE CITY TO ENTER  
INTO TWO (2) COLLECTIVE BARGAINING AGREEMENTS (2016-2017 AND  
2017-2021) WITH THE FRATERNAL ORDER OF POLICE (FOP)(Troy  
Sergeants)**

**WHEREAS**, all full-time sworn sergeants employed by the City of Troy are represented by the Fraternal Order of Police ("FOP"); and

**WHEREAS**, the City of Troy and the FOP have negotiated the terms and conditions of an initial collective bargaining agreement ("CBA")(2106-2017) and a new CBA moving forward (2017-2021), which are attached hereto and incorporated herein as Exhibits A and B, respectively, and the City believes that such terms and conditions are in the best interest of the health, safety and general welfare of its citizens; and

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TROY, ILLINOIS, AS FOLLOWS:**

1. The recitals set forth above are hereby incorporated herein as if fully set forth.
2. The Agreements between the City of Troy and the FOP attached hereto and incorporated herein as Exhibits A and B are hereby adopted. The Mayor is hereby authorized and directed to execute and the City Clerk to attest the CBAs and any such other documents which may be necessary or convenient to implement the terms of the CBAs or this Ordinance upon union ratification of the CBAs.
3. If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.
4. This Ordinance shall be in full force and effect upon its passage, approval and publication as required by law. It may be published in pamphlet form.

PASSED by the City Council of the City of Troy, Madison County, Illinois, approved by the Mayor, and deposited in the office of the City Clerk this 17<sup>th</sup> day of July, 2017.

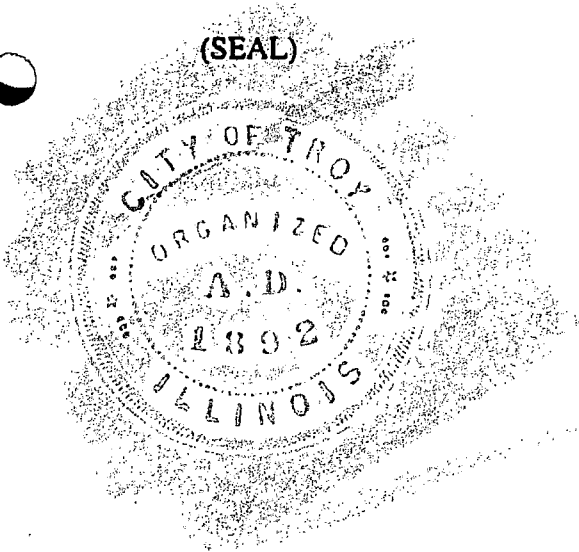
