**RESOLUTION NO. 2017 -01**

**A RESOLUTION OF THE CITY OF TROY, ILLINOIS  
SUPPORTING THE CITY'S GRANT APPLICATION FOR THE  
ILLINOIS DEPARTMENT OF TRANSPORTATION  
FY18-21 TRANSPORTATION IMPROVEMENT PROGRAM  
CONGESTION MITIGATION AND AIR QUALITY (CMAQ) FUNDS**

**WHEREAS**, the City of Troy, Illinois, has identified an opportunity to improve the intersection at Route 162 and Old Troy Road by installing a modern roundabout through the use of federal Congestion Mitigation and Air Quality (CMAQ) funds and funds provided by the City of Troy, Illinois, and potentially other municipal partners; and

**WHEREAS**, the City of Troy, Illinois, recognizes that the Old Troy Road corridor is in very poor condition, although improvements are planned to the route north of Bouse Road by the Village of Glen Carbon, Illinois, in the next fiscal year; and

**WHEREAS**, without the intervention by the City of Troy, Illinois, in the improvement of the intersection of Old Troy Road at Route 162, the intersection will continue as a deficient transportation juncture between the communities of Maryville, Glen Carbon and Troy with a confusing and congested layout with poor sight distances, poor road conditions, and multiple safety issues; and

**WHEREAS**, the Illinois Department of Transportation identified the intersection for improvement with a modern roundabout with an Intersection Design Study in 2006, where the estimated control delay at the existing intersection during the PM peak hour is 26.5 seconds/vehicle (Level-of-Service D); and

**WHEREAS**, the improvement of this intersection to a modern roundabout will improve intersection operations, will reduce confusion and will improve sight distance, as well as reduce the overall control delay at the intersection to 11.56 seconds/vehicle (Level-of-Service B), for the estimated 2,890 vehicles that enter the intersection during the PM peak hour; and

**WHEREAS**, on January 10, 2017, leaders from the Village of Maryville, the Village of Glen Carbon, the City of Troy, and Collinsville Township, would jointly pursue a CMAQ application for federal funds for the construction of a modern roundabout at the intersection of Old Troy Road and Route 162, with the City of Troy, Illinois, leading as the application sponsor; and

**WHEREAS**, the City of Troy, Illinois, seeks to enhance the livability of its citizens by pursuing an Illinois Transportation Improvement Program CMAQ grant for 80 percent (\$884,000) of the total estimated cost of the project (\$1,105,000) to improve the intersection at Old Troy Road and Route 162 with a modern roundabout, with the local match of an estimated \$221,000.


**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TROY, ILLINOIS, AS FOLLOWS:**

1. The recitals set forth above are hereby incorporated herein as if fully set forth.
2. The City of Troy, Illinois, apply for an Illinois Transportation Improvement Program CMAQ grant under the terms and conditions of the State of Illinois Department of Transportation and enter into and agree to the understandings and assurances contained in said applications.
3. That the Mayor on behalf of the City of Troy, Illinois, execute such documents and all other documents necessary for the carrying out of said grant applications.
4. That the Mayor is authorized to provide such additional information as may be required to accomplish the obtaining of such grant.
5. This Resolution shall be in effect following its passage, approval and publication as provided by law.
6. Any and all Resolutions, sections or subsections of Resolutions in conflict herewith are hereby repealed.
